- Leverage all statewide resources in a coordinated, comprehensive approach so as not to duplicate efforts.
- Expand and utilize data to inform decision-making.
- Promote evidence-based practices in medicine, behavioral health, and prevention.
- Address stimulant use disorder in addition to opioid use disorder where appropriate and applicable.
- Reflect the cultural and geographical diversity of our state in our materials, education, and messaging.



AvoidOpioidSD.com has been developed to address opioid abuse and misuse in the state. It provides information to help South Dakotans understand what opioids are, the risk factors involved with use, action steps we can take to keep our communities and families safe, and services available to help those struggling with addiction. **Key features include:**

Resource Hotline: 1-800-920-4343

Available 24 hours a day, 365 days a year. It's free and confidential. Trained specialists can connect South Dakotans with Care Coordination, social support, counseling, treatment options, and services in their area.

Care Coordination

Care Coordinators provide support individuals and families may be missing and will help them develop a plan for recovery. Care Coordination is free, confidential and available by calling the Resource Hotline.

Medication-Assisted Treatment (MAT)

MAT is one of the most effective and safest options available for Opioid Use Disorder (OUD). FDA-approved medications used in combination with counseling and behavioral health therapies provide a whole-patient approach to treatment tailored specifically to each individual. Agencies partnering with DSS to expand MAT services and service providers can be found in the Find Help section.

Take-Back Locations, Events & Prevention

The Take Action section features national Prescription Drug Take-Back Days and a current listing of take-back locations statewide as well as information related to medication safe storage and disposal, how to order free lockboxes and DisposeRx packets, reversing an overdose, and accessing naloxone.

Providers

Providers play a critical role in a patient's recovery. Whether they are referring patients to treatment, connecting families to support services, expanding prescription capabilities, or exploring training opportunities for staff, it's important that they are aware of the options and tools available. As new findings emerge, information will be shared on the website so providers can stay at the forefront of OUD treatment trends, guidelines, and training.

Pharmacy

Pharmacists play a critical role in preventing opioid deaths by increasing statewide access to naloxone. South Dakota pharmacists with an active license can dispense naloxone under the statewide standing order to any eligible person who is at risk of an opioid-related overdose or able to assist an at-risk person (a family member or friend).
